

APPENDIX A

SEIU 517M members referred to Goodman Acker, P.C. by SEIU 517M, shall be entitled to the reduced attorney fees for the legal services referenced below:

I. **Auto Accident Claims**

- a. Third Party attorney fees reduced from 33 1/3% to 25%
- b. First party attorney fee reductions
 - i. Pre Litigation: First Party Benefits Claim administration fees would be reduced from 20% to 15% with the exception of attendant care benefit claims, for which the fees reduced from 33 1/3% to 25%
 - ii. Post Litigation: First Party Benefits attorney fees reduced from 33 1/3 to 25%

II. **Social Security Claims**

- a. The standard attorney fees, regulated and paid directly by the Federal Government, is 25% of the awarded back pay with a maximum of \$6,000.00. Goodman Acker, P.C. will reduce attorney fee to 20% with a maximum of \$6,000.00

III. **Premises Claim** attorney fees reduced from 33 1/3% to 25%

IV. **Medical Malpractice** attorney fees reduced from 33 1/3% to 25%

V. **Product Liability** attorney fees reduced from 33 1/3% to 25%

VI. **Short and Long Term Disability** attorney fees reduced from 33 1/3% to 25%

- **BANKRUPTCY** \$1,000-\$1,500 Retainer + Filing Fee (\$335) + Hourly Fee (Varies depending on complexity of bankruptcy)
- **CRIMINAL** \$500-\$1,000 Retainer + Hourly Rate (Varies depending on charge)
- **DIVORCE/FAMILY LAW** \$1,000-\$5,000 Retainer + Hourly Rate (Average of \$275 per hour)
- **EMPLOYMENT LAW** 25% Contingency Fee

- **JUVENILE NEGLECT** - \$235 Hourly Rate + Retainer Fee
- **MEDICAL EQUIPMENT PRODUCT LIABILITY** 25%
- **MEDICAL MESH** Contingency – 33.3% (1/4 fee for gross settlement of \$100,000 or less; 1/3 fee for gross settlement of \$101,000 or more)
- **PATENT/TRADEMARK** \$400 an hour or flat rate between \$8-\$15K
- **POLICE BRUTALITY:** 25%
- **PROBATE** \$235-\$280 Hourly Rate + Retainer Agreement
- **UNEMPLOYMENT APPEALS** : 25% contingency fee.
- **WORKERS COMPENSATION:** 15% of first \$25,000; 10% of any settlement over \$25,000
